- **What:** 6th Annual Wayne County Bike Tour and 2018 main fundraiser for the Wayne County Cardinal Greenway featuring multiple lengths from an easy 5 mile ride to an experienced 56 mile ride. All rides begin and end touring Wayne County and our hidden gem, The Cardinal Greenway.
- **When:** September 29, 2018
- **Registration** will be available online, at early registration pick-up September 28th, and day of event
- **Registration Fee:** \$25 by July 31; \$30 8/1-9/28; \$35 day of event/\$15 student rate  
Family rate: 2 adults/2 children \$80; \$70 by 7/31
- **Riders** can purchase commemorative event performance t-shirts for \$10. \*Must register by 9/10
- **Route:** at 201 East Main Street (Health Department Lot) riders will cross Main Street traveling on North 3<sup>rd</sup> passing Family Fitness Works and Cycling Fitness Warehouse. The riders will enter the trail at D Street Trailhead and enjoy as many miles as they intend to ride at their leisure.
- **Start Time:** The ride will begin at 8:30a.m. With a staggered start. The longer ride will be released first.
- **Participants:** We have approximately 300 riders annually for this event. We are expecting riders from near and far and all fitness abilities.
